Water Quality Experts Address Carpinteria's Water Quality Issues

Carpinteria Valley Water District hosted a special Water Issues Study Group meeting on November 15th at Carpinteria City Hall. The meeting focused on water quality issues of concern to the Carpinteria Valley. Featured guests included Michael McGuire, PhD, a renowned water quality expert, Cindy Forbes, P.E., Chief of the Southern California Branch, and Kurt Souza, P.E., Chief of the Southern California Section of the California Department of Health Services—Drinking Water Field Operations Branch. Dr. McGuire noted that Carpinteria Valley Water District currently meets existing water quality standards, but can expect a challenge with the new disinfection byproduct standards soon to be announced. The District plans to blend groundwater, making use of the storage tank now under construction, to help meet the challenge.

Q. Why does Ag get a lower water rate?

A. Agricultural water accounts deliberately receive a lower water rate. The rate does not pass along the District costs for drinking water, except for their residential use. This is because growers don't need drinking water for their irrigation. They do, however, pay their proportionate share of State water costs and all other water costs. There is also another basis for charging Ag customers a lower rate. Many growers have the ability to drill wells and many already have. If more growers drilled wells, because the District's price of water got too high, there would be a loss of water sales revenue to the District. The difference would then have to be collected from all other residential and commercial customers, causing their water rates to go up. Agricultural water sales now account for approximately twenty-five percent of the District's overall water revenue.
