Transfer of Water Allotment to Plains Exploration and Production (PXP)

Carpinteria Valley Water District is in the process of finalizing an agreement to transfer 400 acre feet per year of it's 2000 acre feet Central Coast Water Authority (CCWA) Project Allotment.

Recent studies have indicated that CVWD has excess water during normal and wet years through 2030. The District has also determined that during a prolonged drought various other water reliability strategies will meet the District's water needs.

The transfer is expected to take place during a five year option period. PXP will pay CVWD \$750 per acre foot or a total of \$300,000 per year to hold the option before a transfer occurs. This transfer will result in a reduction of the State Water Project (SWP) charge on customer bills and help reduce overall water rate increases.

Main Line Flushing

The Carpinteria Valley Water District will begin its annual water quality flushing program in May and will continue through June. The purpose of this program is to improve water quality by removing some of the older water trapped in the distribution system. The flushing program also helps remove mineral deposits and sediment.
