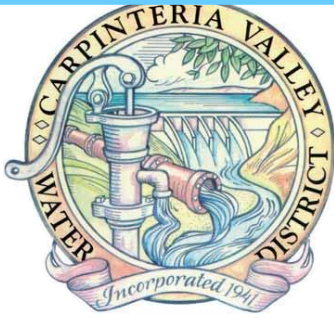

## *Crew Works Through Night to Repair Leak*

Repairing leaks is one of the many tasks performed by CVWD field personnel and more often than not, the repairs are made with minimal, if any, impact to customers. On Thursday, January 4th, at approximately 4:00 p.m., a routine repair in the vicinity of 6900 Casitas Pass Road was hampered when the valve ruptured and sent water surging out of the main pipeline. Foreman Danny Rada and field crew members, Joel Cox and Daniel Rodriguez, pictured here, immediately began the process of locating and shutting down subsequent valves in order to contain and repair the leak. Approximately fifty-five accounts were affected by the repair work and loss of water. Assisted by General Manager, Charles Hamilton, Engineering staff, Bob McDonald and Brian King as well as Water Treatment Operators, Greg Stanford and Joey Mendoza, the crew, worked tirelessly throughout the night temporarily repairing the valve so that customers would have water to meet their early morning water demands. On Friday, January 9th, District field personnel along with a contractor were able to replace the temporary valve repair job with a new permanent valve.

**Q.** Why is my water usage this month exactly the same as last month? Is my meter actually being read?

**A.** Yes, your meter is read each month. It is in fact read by different field personnel each month. There is usually very little variation in water usage from month to month unless we have had very wet or dry weather. Other reasons for increased water use can be attributed to company or family visiting during the holidays, leaks, or newly installed landscaping. Some reasons for decreases in water use can be due to water use efficiency, vacationing residents or less family members present in household.
