## Carpinteria Valley Water District Water Quality Improvement &

Water Main Flushing Program 2007

Carpinteria Valley Water District began its annual water quality flushing program February 12th and plans to continue the program through April.

The purpose of this program is to improve water quality. Flushing removes a percentage of the water in the distribution system that may have been in the system a long time.

The flushing program also helps remove mineral deposits and sediment from the distribution system that may cause discoloration of the water from time to time.

The District will inform customers of the affected areas by posting flushing signs on barricades and placing them in visible locations for residents.

The hours for main flushing are from 9pm-3am. It is recommended that affected customers avoid doing loads of laundry during the flushing hours.

Some customers who use water during the flushing hours may see some discoloration of the water. While aesthetically discomforting, please keep in mind that this is a temporary problem that will clear up quickly and is not a risk to your health.

It also ran a notification in the July 13, 2006 edition, **Briefly** column, titled **Local** *election filing period begins Monday.* There were also letters in the *View* section of the <u>Coastal View</u>. In addition, there were was an article in the <u>Santa Barbara NewsPress</u> on August 10, 2006 that mentioned the election filing period. Lastly it was announced in the July 26th, 2006 Board of Directors Agenda, posted outside the District offices and on the CVWD website. Two board members will be up for reelection in November 2008.
