## What Are We Doing About the High Rates?

A message from the General Manager.

A customer recently asked me what the District is doing about its high water rates compared to other agencies in Santa Barbara County. I first gave a short answer about why they keep going up: It just costs a lot of money to build new and replace old waterworks facilities.

But then I started telling him about steps the District has taken and is taking now that will significantly improve the financial outlook for the District and greatly reduce the upward pressure on the water rates. These steps have to do with the sale or transfer of some of the District's 2,000 acre feet of State Water allocation. It is now evident that the District overinvested in 1991 in State Water as a backup source of supply.

## **Plains Exploration and Production (PXP)**

The Board agreed in 2006 to sell up to 400 acre feet of State Water allotment to PXP. This option-to-buy agreement currently brings in \$300,000/year that would otherwise have to be collected from Carpinteria Valley customers to help pay down the District's annual \$3 million State Water debt obligation. If the agreement is consummated, the annual benefit jumps to \$600,000, and the District may also receive a much as \$2 million in cash as an equity buy-in.

#### City of Guadalupe

The District has begun formal negotiations to sell up to 500 acre feet of State Water Allotment to the City of Guadalupe. Such a sale would benefit the District greatly, in the same manner as the PXP sale.

Other parties have also inquired about the District's State Water and may soon begin formal discussions with the District as well.

In the meantime, the District this year also secured participation in a unique water banking opportunity in Kern County to store unneeded State Water for later use – for up to five years. This agreement with the Irvine Ranch Water District involves a multi-agency network including the Central Coast Water Authority, the Kern County Water Agency, the Rosedale Rio Bravo Water Storage District, and the California Department of Water Resources.

# Proposed Water Rates

The Board of Directors has revised the proposed rate schedule, beginning with the July 2008 billing period. Six (6) units of water is now the proposed minimum for the first tiered rate for all customers. This action will lower projected water bills for customers with a low Base rate (less than 6 units).
