

Last month, Governor Schwarzenegger proclaimed a statewide drought and issued an Executive Order to deal with the water supply crisis. The crisis is the result of two consecutive years of below-average rainfall, very low snowmelt runoff and court-ordered restrictions on water transfers through the State Water Project facilities in the Sacramento-San Joaquin Delta.

Although the Governor declared the drought statewide, the severity varies from region to region across the state. The South Coast region, which includes the Carpinteria Valley, is fortunate that Lake Cachuma filled completely from rainfall during the past winter. The District has, therefore, felt little impact by the court action that restricts the timing and extent of transfers of water through the Sacramento-San Joaquin Delta. Moreover, CVWD's groundwater supply and local storage capabilities augment the water supplied from Lake Cachuma. These factors help reduce the impact of the statewide water shortage on Carpinteria Valley's water supply.

A key element of the Executive Order is to expedite water conservation at the local level. CVWD supports this effort and strongly encourages all Carpinteria Valley customers to use water efficiently both indoors and out. One way to increase awareness and make a personal commitment to reduce water use is by taking the "20 Gallon Challenge" at <u>www.sbwater.org</u>. The challenge allows water users to develop personalized plans to increase water conservation efforts. In addition, the District provides free water check-ups to help customers find leaks, weather-based irrigation controllers to qualifying customers, and low water using plant information. The District drought tolerant demonstration garden is available for self-guided tours. A list of plants is also available. Water saving tools such as low-flow garden nozzles, 1.5 gallon per minute (gpm) showerheads and shower timers are available for purchase at the District office. Saving a little bit of water every day will benefit our water supply and the Carpinteria Valley community.
