### Public Invited to Participate in Public Hearing for Urban Water Management Plan

Carpinteria Valley Water District (CVWD) is planning to hold a public hearing on its Urban Water Management Plan (UWMP) in late May. The document serves as a long-range planning document for water supply and demand as well as provides an overview of the District's water supply, usage and conservation programs.

In 1983, the California Legislature enacted the Urban Water Management Planning Act (Division 6 Part 2.6 of the Water Code §§10610-10656). The Act states that every urban water supplier which provides water to 3,000 or more customers, or provides more than 3,000 acre-feet of water annually, should make every effort to ensure the appropriate level of reliability in its water service that is sufficient to meet the needs of all its customers during normal, dry, and multiple dry years. The UWMP examines historic and current water use projections and compares projected water supplies with demands over the next 20 years. CVWD's plan will detail the sources of our water supply and explain how the District intends to meet future water demands. The plan is meant to help ensure that CVWD provides a reliable supply of high-quality water to customers and meets current and future water demands.

#### Quick Response Keeps Water Supply Safe

Saturday, April 10, 2011 at about 11:30 p.m., the District received an alarm identifying the failure of one of its main water disinfection chemical feed pumps.

The automated call out system alerted District staff to the failure which allowed for a quick response and evaluation of the facility by Water Distribution Foreman, Danny Rada, standing on the left with Water Treatment Foreman, Greg Stanford.

Utilizing a back-up pump, Mr. Rada was able to continue disinfection of the water supply without interruption to District customers or further damage to the failed pump.

The Carpinteria Valley Water District continues to evaluate and improve its water system as a commitment to ensure that all State and Federal regulations are met and the community of Carpinteria Valley continues to receive safe drinking water.
